

2017 Dr. Rather G. Brown Scholarship Application Huntsville-Madison County Alumni Chapter Alabama Agricultural and Mechanical University

The Dr. Rather G. Brown Scholarship is based primarily on scholarship merit and leadership potential. The Scholarship is granted in the amount of \$1,500 towards Fall semester 2017 expenses. All required application materials must be postmarked by Monday, March 20, 2017. Download application from <http://www.aamuhsv-madisonalumni.org/resources.html>.

Eligibility

To be eligible for consideration of the Dr. Rather G. Brown Scholarship, the following applies to all applicants:

- Must be a graduating high school senior enrolled in a Madison County, Madison City, Huntsville City School, or parochial and private institution in Madison County OR a current AAMU undergraduate student who is a Madison County resident and in good standing.
- Must provide a complete scholarship packet postmarked by Monday March 20, 2017.
 - Packets received after the deadline will not be considered.
 - Incomplete packets will not be considered.
- Must have an ACT score of 18 or above
- Current AAMU undergraduate students must have a cumulative GPA of 2.50 and have completed 15 semester credit hours.

Award Criteria

Scholarship recipients will be notified by April 14, 2017 and recognized prior to the end of the 2016-2017 school year. Upon the verification of enrollment and registration at Alabama A & M University, the scholarship will be awarded in the month of September 2017. Failure to provide verification of enrollment and registration will result in forfeiture of the scholarship.

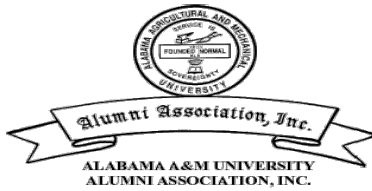
Scholarship Application Procedures

- Submit completed scholarship application via mail postmarked by Monday Monday March 20, 2017.
- Submit ACT scores verified by school counselor (unofficial copy is acceptable).
- Request an official copy of your latest high school or college transcript to be sent to the alumni chapter address below postmarked by March 20, 2017.
- Submit letters of recommendation via mail and postmarked by March 20, 2017.

Scholarship packet contents

- **Official transcripts (all applicants)**

- **Completed Application with signed Affirmation Statement (all applicants)**
 - **Typed essay**
 - Prepare an essay (Arial Font, 12pt, 500 words maximum) that addresses the following question: Explain the significant role that Alabama A & M University plays in the Huntsville/Madison County Community?
 - **Personal statement (Arial Font, 12pt, 250 words maximum)**
 - Describe yourself including your hobbies, educational, and career goals

- **Two letters of recommendation, on the provided form, from a high school counselor, teacher, or person of choice from the community (examples include clergy, mentor, coach, advisor, supervisor) (all applicants)**
 - Letters should be mailed directly from the recommender to the alumni chapter address.
 - Current AAMU students must provide at least one of the two recommendation letters from a past or present professor, supervisor, advisor, or dean from AAMU.

- **ACT score** – unofficial copy verified by high school counselor mailed directly to the AAMU alumni chapter Post Office Box. (high school applicants only)
